MARGARITA RIBAS RIERA, TESORERO ACCIDENTAL, JEFE DE LOS SERVICIOS DE RECAUDACIÓN DEL AYUNTAMIENTO DE EIVISSA PROVINCIA DE BALEARES. HACER SABER: Que en el expediente administrativo de apremio que instruye contra los deudores que al final se relacionan, cuyo paradero no ha podido averiguarse, en virtud de los débitos a favor de la Hacienda Local por los conceptos, ejercicios e importes que se consignan y habiendo transcurrido el periodo voluntario para el pago de las deudas que posteriormente se relacionaran, se ha dictado por el Sr. Tesorero del Ayuntamiento, la siguiente:

PROVIDENCIA DE APREMIO: “En uso de las facultades que me confiere el artículo 5.3.c) del Real Decreto 1174/1987, de 18 de septiembre, en relación con los artículos 161 y 167 de la Ley 58/2003, de 17 de diciembre, General Tributaria y artículos 69 y 70 del Reglamento General de Recaudación, respecto a las deudas que no han sido satisfechas en el correspondiente plazo de ingreso en período voluntario, finalizado el mismo y comenzado el devengo de intereses de demora, procedo a liquidar los recargos del período ejecutivo que corresponda, a que se refiere el artículo 28 de la Ley General Tributaria, requiriéndole expresamente para que efectúe el pago de la deuda no ingresada, y del recargo de apremio reducido del diez por ciento, con la advertencia de que, si no se realiza en los plazos del artículo 62.5 de la Ley General Tributaria, se procederá al embargo de sus bienes y derechos patrimoniales o garantías existentes y el recargo que deberá satisfacer será el recargo ordinario de apremio del veinte por ciento de la deuda no ingresada, así como se exigirán los intereses de demora devengados desde el inicio del periodo ejecutivo.”

Así mismo se les hace saber que contra la transcrita Providencia, se puede presentar recurso DE REPOSICIÓN, en el plazo de UN MES, ante el Sr. Tesorero de este Ayuntamiento. Contra la denegación expresa o tácita de dicho recurso de reposición, podrá interponerse recurso Contencioso-Administrativo ante la Sala de lo Contencioso de Palma de Mallorca, según lo dispuesto en los Art. 45 y siguientes de la Ley Jurisdicción Contencioso-Administrativa, Disposición Adicional 5ª de la Ley 30/92 de Régimen Jurídico de las Administraciones Públicas y del Procedimiento Administrativo Común, y Art. 52 y 108 de la Ley 7/85 de 2 de Abril Reguladora de Bases de Régimen Local.

Intentada por dos veces la notificación a las personas y entidades que posteriormente se relacionaran, relativas al procedimiento ejecutivo en la vía de apremio que se instruye por este Servicio de Recaudación Municipal y no habiendo podido tener efecto por causas no imputables al mismo, se cita a los interesados ó sus representantes para que, en el plazo de quince días naturales, contados a partir del siguiente al de la publicación del presente anuncio, comparezcan en las oficinas de este Servicio sitas en la Calle Canarias, 35-1º de Eivissa, a los efectos de que les sea practicada la respectiva notificación, significándoles que, de no comparecer en el plazo, la notificación se entenderá producida a todos los efectos legales desde el día siguiente al del vencimiento del plazo señalado para comparecer. Ello de conformidad a lo dispuesto en el artículo 112, apartado 1 y 2 de la Ley 58/2003, General Tributaria.

En cumplimiento del Art. 71 del Reglamento General de Recaudación, se advierte a los interesados de lo siguiente:

1º) Los plazos del ingreso de los débitos son los siguientes:

- a) Las notificadas entre los días 1 y 15 de cada mes, hasta el día veinte de dicho mes o, si no fuera hábil, el inmediato hábil siguiente.
- b) Las notificadas entre los días 16 y último de cada mes, hasta el día cinco del mes siguiente o si no fuera hábil, el inmediato hábil siguiente.

2º) Lugar de ingreso: en los Servicios de Recaudación del Ayuntamiento de Eivissa, sitos en Calle Canarias, nº 35 1er piso, 07800 Eivissa, de 9 a 14 horas de lunes a viernes.

3º) Formas de pago: a) dinero de curso legal; b) cheque conformado a favor del Excmo. Ayuntamiento de Eivissa, c) giro postal.

4º) Que caso de no efectuar el ingreso en dicho plazos, se procederá sin más al embargo de sus bienes o a la ejecución de las garantías existentes.

5º) Sobre la liquidación de intereses de demora y repercusión de costas del procedimiento.

6º) De la posibilidad de aplazamiento o fraccionamiento de pago.





7º) De que no se suspender el procedimiento de apremio, salvo en los casos y condiciones previstos en el Art. 165 de la Ley General Tributaria.
