

COVENANT OF MAYORS TERRITORIAL COORDINATORS' COMMITMENT STATEMENT Consell Insular de Menorca

WHEREAS

The European Commission launched the Covenant of Mayors in 2008 to endorse and support the efforts deployed by local authorities in the implementation of sustainable energy and climate policies.

The Covenant of Mayors for Climate and Energy is a bottom-up movement that brings together municipalities of all sizes which voluntarily commit to implement EU climate and energy objectives through an integrated approach to climate change mitigation and adaptation.

Regional and sub-national authorities share the responsibility for climate action with authorities at the local level.

The European Commission recognises them as important allies to support Covenant of Mayors signatories to meet their commitments and increase the impact of the Covenant.

WE, COVENANT TERRITORIAL COORDINATORS,

Are public authorities (provinces, regions...) that are in a position **to provide strategic guidance, technical and financial support** to Covenant of Mayors signatories and municipalities willing to sign up to it;

Endorse the Covenant of Mayors vision towards **decarbonised and resilient** territories, where citizens have access to **secure, sustainable and affordable energy**;

Acknowledge that our commitment implies working using a **cross-sectoral** and **multi-level cooperation** approach (i.e. across policy sectors, departments and between authorities at regional and other governance levels) including active stakeholder involvement, for more efficient and integrated action;

Publicly recognise the Covenant of Mayors as a key element of our political strategy and;

Stand ready to support all Covenant signatories in the delivery of practical and long-term measures towards a healthy, socially fair and economically-viable environment for present and future generations.

- **Promote accession** to the Covenant of Mayors

- This statement shall be renewed automatically every year unless decided otherwise by our administration

ANNEX – COVENANT TERRITORIAL COORDINATORS' ACTIVITIES

Covenant Territorial Coordinators are required to report regularly on their activities using an online questionnaire. This annex provides examples of activities they may carry out, according to each Covenant Territorial Coordinator's own areas of expertise and competence. It is to be used as a basis for completing the reporting questionnaire to be sent at least every two years to the Covenant of Mayors Office.

- **Promote accession to the Covenant of Mayors**
 - Dissemination of the [Covenant promotional and/or technical materials](#)
 - Adaptation/translation of the [Covenant promotional and/or technical materials](#) or development of specific publications on the initiative
 - Promotion through own communication tools/channels (e.g. newsletter and blogs, website, mailing lists, social media, etc.)
 - Organisation of dedicated [events](#) (e.g. workshops, seminars, conferences)
 - Other
- **Provide technical and strategic assistance to signatory municipalities**
 - Setting-up of technical working group(s) or equivalent
 - Development of technical guidelines or adaptation of the [existing ones](#) (e.g. SECAP guidebook, [reporting guidelines](#) or other reference guides, [Urban Adaptation Support Tool](#))
 - Provision of support to signatories in the development, implementation and monitoring of their SECAPs
 - Collaboration with stakeholders for the provision of technical support (e.g. through cooperation agreement(s) with energy/environment agencies or consultancies, universities or research agencies)
 - Other
- **Provide financial support to signatory municipalities**
 - Through the creation of dedicated funds/subsidies/grants
 - By providing information and helping signatories apply for dedicated funds/subsidies/grants/calls for projects, etc.
 - By making full use of the European funds to support climate and energy action at local and regional level
 - By co-ordinating joint projects (e.g. submitting an ELENA-EIB proposal which would bundle small projects...)
 - By promoting alternative schemes benefitting municipalities and/or citizens (e.g. use of Energy Performance Contracting, crowdfunding, cooperatives, etc.)
 - Through specifically assigned in-house staff
 - Other

- **Support experience and knowledge-sharing amongst existing and potential Covenant Signatories**
 - Creation of experience-sharing opportunities amongst signatories (e.g. events, discussion forums, blogs, peer-review and mentoring by experienced signatories)
 - Promotion of signatories' activities (e.g. through case studies or news items)
 - Suggestion of tools and materials relevant for signatories to be added to the [Covenant Capacity-sharing Corner](#)
 - Other

- **Work in partnership with all the other Covenant Coordinators and Supporters within the territory of its competence**
 - Setting-up of a steering committee/working group aiming at facilitating the implementation of the Covenant of Mayors in the territory
 - Development of joint activities with key stakeholders in the territory (e.g. associations and agencies, chambers of commerce, trade unions, citizen organisations, universities and research institutes...)
 - Regular exchanges with other Covenant Coordinators and Supporters in the territory
 - Involvement in the regional/national Covenant of Mayors club(s) or similar exchange platform(s) if any
 - Other

- **Participate in Covenant of Mayors activities and report regularly to the Covenant of Mayors Office**
 - Submission of good practice examples through the online [catalogue of Benchmarks of Excellence](#)
 - Contribution to the [Covenant Capacity-sharing Corner](#) (e.g. resource library, discussion forums)
